EXECUTIVE SUMMARY

The Office of Children's Services (OCS) completed has an audit Charles City-New Kent CSA Program. The Charles City-New Kent CSA Program provided services and funding to 25 eligible youth and families in fiscal year (FY) 2023. The audit included reviewing and evaluating management oversight, operational, and fiscal practices. Based on the review and examination of the Charles City-New Kent CSA Program and supporting documentation provided, internal controls governing management oversight operational, and fiscal practices were determined as adequate and functioning as intended. No significant, reportable non-compliance issues were observed. Notable accomplishments of the Charles City-New Kent Community Policy and Management Team (CPMT) included the following:

INTRODUCTION

The Office of Children's Services has completed a financial/compliance audit of the Charles City-New Kent CSA Program. The audit was conducted in conformance with the International Standards for the Professional Practice of Internal Auditing (Standards). The standards require planning and performance of the audit pursuant to stated audit objectives to provide a reasonable basis for audit observations, recommendations, and conclusions. The audit was completed on April 30, 2024, and covered the period from March 1, 2023 through February 29, 2024.

The objectives of the audit were:

- To determine whether adequate internal controls have been established and implemented over CSA expenditures.
- To determine the adequacy of training and technical assistance by assessing local government CSA staff knowledge and proficiency in implementing local CSA programs.
- To assess whether operations have maintained high standards for sound fiscal accountability and ensured responsible use of taxpayer funds by evaluating fiscal activities of the local CSA program.
- To assess the level of coordination among local government CSA stakeholders and efforts to improve CSA performance by evaluating the local CSA program's operational and utilization review practices.
- Assess the implementation of quality improvement plans addressing prior audit observations reported by OCS and/or identified in the prior self-assessment evaluations completed by the Charles City-New Kent CPMT. The audit report dates were July 31, 2018, for Charles City County and April 22, 2019, for New Kent County, respectively.

The audit scope included all youth and their families who received CSA-funded services during the audit period. Audit procedures included reviews of relevant laws, policies, procedures, and regulations; interviews with various CSA stakeholders; flowcharts of operational and fiscal processes; various tests and examination of records; and other audit procedures deemed necessary to meet the audit objectives.

BACKGROUND

Charles City County and New Kent County are in the Greater Richmond Region of the Commonwealth of Virginia. Established in 1619, Charles City County was one of Virginia's first four "boroughs" and one of the oldest governmental units in America. According to the U.S. Census Bureau Quick Facts 2023, Charles City County's estimated population was 6,610. The median household income from 2018-2022 was \$65,573. Split from York County, New Kent County was established in 1654. According to the U.S. Census Bureau Quick Facts 2023, New Kent County's estimated population was 26,134. The median household income from 2018-2022 was \$113,120. In 2021, Charles City and New Kent Counties combined resources to provide local administration of the Children's Services Act program.

The Children's Services Act (CSA) is a law enacted in 1993 that establishes a single state pool of funds to purchase services for eligible youth and their families. The state funds, combined with local community funds, are managed by a local interagency team, the Community Policy and Management Team (CPMT), that plans and oversees services to youth. Charles City-New Kent CPMT is supported by two Family Assessment and Planning Teams (FAPT) responsible for recommending appropriate services to eligible children and families. Administrative services are managed through the local CSA office staffed by the CSA Coordinator. Expenditure demographics for fiscal years 2020 to 2023 are depicted below.
