Call to Order/Opening Remarks

Secretary Littel called the meeting to order at 9:35 a.m. and welcomed everyone. Members approved the requests made by Supervisor Palchik and Dr. Jaberi pursuant to §2.2-3708.2 and SEC Policy 2.1.3 to participate virtually from their homes due to medical reasons.

Member introductions were made.

Approval of Minutes

The minutes of the December 9, 2021 meeting were approved on a motion by Margaret Angela Franklin, seconded by Lesley Abashian, and carried.

Public Comment

There were no public comments.

Overview of the State and Local Advisory Team (SLAT)

Lesley Abashian, SLAT Chair, provided an overview of SLAT's role in support of CSA and the SEC. Membership on SLAT includes representatives from state and local government entities, the judiciary, a private provider, and a family representative.

SLAT keeps apprised of initiatives, such as Family First, and legislative activities that impact CSA and other child-serving agencies. They also work closely with the CSA Coordinators' Network and are currently working with that group on a guidance document pertaining to best practices and lessons learned during the pandemic when hosting virtual Family Assessment and Planning Team (FAPT) meetings.

As part of the SEC Strategic Plan, SLAT developed a report outlining the leadership competencies of local CSA coordinators, Community Policy and Management Team (CPMT) members and FAPT members. SLAT also developed a *Guide to the Children's Services Act for Youth and Families*.

In closing her report, Mrs. Abashian noted that her term as SLAT Chair will be ending June 30. She encouraged the SEC to utilize SLAT as a resource to provide assistance to the SEC with the SEC's projects and initiatives.

OCS Executive Director's Report

Mr. Reiner reported on the following items:

Legislation – Amendment to the CSA code in regards to who may serve as a parent representative on FAPTs and CPMTs. The Code has restricted those who as a part of their employment, interact directly on a regular and daily basis with children or supervise employees who interact directly on a daily basis with children from serving as a parent representative. This legislation removes that restriction, although those who do not serve in those capacities are prioritized for participation where practicable. (Mr. Reiner noted that historically localities have had a difficult time recruiting parent representatives to serve on FAPT and CPMT.)

Additionally the legislation directs the SEC to inventory current efforts to recruit and retain parent representatives to serve on FAPTs and CPMTs and to compile a list of best practices for

including and elevating parent voices within FAPTs and CPMTs, particularly parents and caregivers with lived experience. A report is due November 1, 2022.

**Budget* - Included in Governor Northam's introduced budget: \$50,000 increase in training funds; one additional IT position, and funding for dual-factor (IT systems) authentication. Active budget amendments include:

- o \$1.0M in administrative funds to increase local support for CSA administration/operations
- o a 12-month delay in the implementation of rate-setting for private day special education programs with a validation and fiscal impact analysis (Senate only). It is not clear what this validation would involve.
- SEC Strategic Plan Members received an updated copy (December 2021) of the SEC Strategic Plan. Mr. Reiner will provide a more detailed report at a future meeting.
- Program Update In accordance with changes to the powers and duties of OCS to
 provide for the effective implementation of CSA in all localities, OCS has added an
 additional program consultant who has been working with local programs identified as
 consistently underperforming. Corrective action plans for each of the identified localities
 will be developed for submission to OCS and the SEC.
- CSA Annual Conference The Conference will be held at the Hotel Roanoke and Conference Center, November 1-2, 2022.

Overview of the OCS Audit Program

Stephanie Bacote, OCS Program Audit Manager provided an overview of the OCS Audit Program. Mrs. Bacote also provided the members with a copy of the Program Audit Charter, Program Audit Activity Quick Facts (including a summary of systemic audit observations), and the Audit Plan for Fiscal Years 2020-2023. She noted that the audit team consists of four members with recruitment underway for one of those positions.

She reported that the Program Audit function of OCS was established in 2012 to provide independent, objective assurance and consulting services designed to add value and improve the operations of locally administered CSA programs. These services support CSA to accomplish its objectives by bringing a systemic, disciplined approach to evaluate and improve the effectiveness of risk management, control and governance processes.

The OCS Program Audits evaluate the effectiveness of internal controls and organizational practices applicable to financial and operational activities of CSA. The operating guidelines for program audits are adopted from the Institute of Internal Auditors, International Standards for the Professional Practice of Internal Auditing.

At the end of her presentation, Mrs. Bacote answered questions from the members.

Updates of Relevance to CSA and Services to Children

Karen Kimsey provided a brief update on unwinding of the Medicaid enhanced federal funding provided during the Public Health Emergency, which ends July 1, 2022. Other members

reported on IT projects to enhance data sharing/reporting and outcome measures, addressing workforce and mental health needs and improvements to services and service delivery for the children, youth and families of Virginia.

Closing Remarks and Adjournment

In closing, Secretary Littel thanked everyone for attending today's meeting. The next meeting is scheduled for June 9, 2022.

TRAINING PLAN Fiscal Year 2023

Developed in accordance with Chapter 552 (Appropriation Act), Item 292, Section B.6 Considered by the State Executive Council – June 9, 2022

The Children's Services Act (CSA) vision statement is "A collaborative, child-centered, family-focused, community-based system of care that effectively meets the needs of youth and their families in the Commonwealth." A critical mechanism for achieving this vision is the development and implementation of a robust training plan. Following the provisions of the Appropriation Act, the Office of Children's Services prepares an annual training plan for approval by the State Executive Council for Children's Services (SEC). This document outlines the OCS FY2023 Training Plan (July 1, 2022 - June 30, 2023). The description of potential training topics is intentionally broad, inclusive, and consistent with goals and strategic directions to promote alignment, lead by example, and collaborate on a shared vision and key outcomes. Specific training activities are planned and implemented in response to stakeholder requests and needs, important system-wide initiatives, and the extent of available resources.

I. GOALS

A. To increase the knowledge, skills, and competencies of individuals holding CSAspecific roles and responsibilities to ensure effective implementation of the CSA.

Objectives:

- To enhance effectiveness and positive outcomes for youth and families by ensuring that the core requirements of CSA and the principles of a system of care are known to individuals who serve vital roles within the structures of CSA
- To assure essential competencies in CSA practice are applied to local operations
- To enhance the level of knowledge and skills of core members of local CSA teams (Family Assessment and Planning Teams (FAPT), Community Policy and Management Teams (CPMT))
- To support, encourage, and motivate key CSA participants to realize the mission and vision of the CSA and the system of care through collaboration and excellence in practice

Target Audiences:

- Collect and report information regarding participants (e.g., number, primary professional affiliation) at major CSA training events (i.e., the annual CSA Conference)
- Collect and summarize evaluations of OCS training activities and utilize feedback to refine and improve training activities
- Provide quarterly reports to the State Executive Council summarizing OCS training activities
- Complete and submit an annual report to the General Assembly regarding OCS training activities (Appropriation Act)

ADMINISTERING THE CHILDREN'S SERVICES ACT



The Children's Services Act (CSA, §2.2-5200 et seq) was enacted in 1993 to create a collaborative system of services and funding for atrisk youth and families.

The CSA establishes local multidisciplinary teams responsible to work with families to plan services according to each child's unique strengths and needs and to administer the community's CSA activities.

The Office of Children's Services (OCS) is the administrative entity responsible for ensuring effective and efficient implementation of the CSA across the Commonwealth.

Guiding principles for OCS include:

- Child and family directed care,
- Equitable access to quality services,
- Responsible and effective use of public funds,
- Support for effective, evidence-based practices, and
- Collaborative partnerships across state, local, public, and private stakeholders.



REGIONAL AND STATEWIDE TRAINING REGARDING CSA

Annual Report to the General Assembly, December 2021 In accordance with the 2021 Appropriation Act Chapter 552 Item 292 (B)(6)

The mission of the Office of Children's Services (OCS) is to facilitate a collaborative system of services and funding that is child-centered, family-focused, and community-based when addressing the strengths and needs of youth and their families in the Commonwealth of Virginia. To support this mission, OCS annually develops and implements a robust training plan. In light of the ongoing COVID-19 pandemic, implementation of the FY2021 training plan saw the movement of all planned in-person training events to virtual delivery platforms. In most instances, this required significant reconceptualization and redesign of curriculum and instructional strategies.

Noteworthy this year was the series of three evidence-based practices readiness events for local child-serving teams, coordinated by OCS and with faculty from the National Implementation Research Network (NIRN), these events were planned and supported with both staff and financial resources by agencies from three cabinet secretariats (OCS, DBHDS, DSS, DMAS, DJJ, and DOE). This unique collaborative approach is reflective of the true spirit of the Children's Services Act. Seven hundred local participants from all child serving agencies and other partners gathered virtually in local/regional teams to build knowledge and local readiness to support the Commonwealth's efforts to improve outcomes for children and families through the use of effective interventions.

In accordance with the FY2021 training plan, the following activities were implemented:

- Thirty-eight (38) regional and stakeholder training sessions were provided to 3,678 (non-unique) participants. Training topics, dates, and participant numbers are summarized on pages 2 through 4 of this report. The planned biennial statewide High Fidelity Wraparound Conference was cancelled and could not be rescheduled.
- Seventeen (17) on-line training courses were offered through the Virginia Learning Center and the Praed Foundation CANS (Child and Adolescent Needs and Strengths) training site, with a total enrollment of 5,307 (non-unique) participants.
- The annual CSA Conference attracted almost 1,000 individuals. The virtual
 delivery provided at no-cost to participants represented a significant growth in
 number of attendees over prior in-person annual Conferences. Evaluations
 indicated advantages of virtual delivery (e.g., lower cost of attendance allowing
 greater participation, reduction in need for travel) along with disadvantages
 (e.g., lack of tradition in-person networking opportunities and fewer breakout
 sessions).
- On-line "OCS Help Desk" was maintained with approximately 600 individual requests answered. A significant number of unlogged responses were provided to localities concerning adaptations to the COVD-19 pandemic, including changes to Family Assessment and Planning Team (FAPT) and Community Policy and Management Team (CPMT) meetings.
